CITIZENS PARTICIPATION

Nancy Bronsberg- 663 Shoemake Ave. Has issues with letters she and neighbors received concerning address change. It will be changed from Rear Shoemaker Ave. to Marshall's Lane for public safety. Stated she has had conversations with our Solicitor and 911 supervisor. She said that 911 told her that they had nothing to do with the address changes and that the Borough initiated the change. She was told by administrator that 911 initiated the change not the Borough. Solicitor Lukesh said that a letter was sent to the Mayor about a year ago initiating the changes. She explained that once we were notified and we didn't make the changes, then the Borough would be liable if something happened because we did not change the addresses. Bronsberg stated that her issue in public safety is the condition of the road. She said that changing the street name of that road is not going to solve a public safety issue. Mentioned that GPS only updates once a year. If you call for an outside firefighter, police, outside ambulance or firetruck, following GPS, it will take them to either R. Shoemaker Ave or Marshall's Lane. She said that no one would take a truck up that hill. A discussion followed on this issue
