WEST WYOMING BOROUGH ORDINANCE REPEALING THE ZONING LAWS OF THE BOROUGH OF WEST WYOMING AND ENACTING AND ADOPTING THE LAWS OF THE LUZERNE COUNTY PLANNING COMMISSION AND APPOINTING THE LUZERNE COUNTY PLANNING COMMISSION FOR ENFORCEMENT OF ZONING AND PLANNING IN THE BOROUGH OF WEST WYOMING.

West Wyoming Ordinance Number 2 - 2010

WHEREAS, the Borough of West Wyoming currently handles all legislation of zoning laws for the Borough: and

WHEREAS, the Borough of West Wyoming currently is responsible for enforcement of the zoning laws in the Borough of West Wyoming: and

WHEREAS, it is the desire and intent of the Borough of West Wyoming to have the Zoning and Planning Commission of Luzerne County appointed to enact and enforce zoning for the Borough of West Wyoming.

NOW, THEREFORE BE IT ORDAINED.

THAT, any and all zoning laws, ordinances, resolutions, rules and regulations enacted or adopted by the Borough of West Wyoming shall be repealed on January 25, 2010 and

THAT, contemporaneously therewith, the zoning laws, ordinances, resolutions, rules and regulations of the Zoning and Planning Commission of Luzerne County is hereby adopted to enforce said laws, ordinances, resolutions, rules and regulations in the Borough of West Wyoming as of January 25, 2010 and

THAT, if any section, subsection, sentence, clause or phrase of this ordinance is for any reason, held to be unconstitutional: such decision shall not affect the validity of the remaining portions of this ordinance. West Wyoming Borough Council hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of that fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional; and

THAT, nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired or liability incurred, or any cause or causes or causes of action acquired or existing, under any act or ordinance hereby repealed as cited herein; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance: and

THAT, this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take full force and effect on January 25, 2010; which is the date on which the zoning laws of the Borough or West Wyoming shall be transferred to Luzerne County.
