

ORDINANCE NUMBER 5 of 2015

AMENDED LANDLORD REGISTRATION ORDINANCE OF WEST WYOMING BOROUGH

An ordinance of West Wyoming Borough Council for West Wyoming, Pennsylvania establishing and assessing registration requirements for every owner who owns rental properties within the Borough of West Wyoming.

Whereas, an ordinance establishing and assessing registration requirements on those property owners who own rental properties within the borough of West Wyoming, more specifically requiring landlords and any person who rents property to any individual to register their tenants with the properly authorized agents of West Wyoming Borough.

Whereas, the Borough of West Wyoming, Luzerne County hereinafter "Borough" is desirous of establishing a registration requirement so that all individuals whether residing within the Borough or outside of the Borough, that own property within the Borough and rent or lease said property to tenants are required to notify the authorized agent of the Borough of which tenants reside at each location owned.

Now therefore be it enacted and ordained and it is hereby enacted and ordained by the Council for the Borough of West Wyoming as follows:

Section 1.

Every owner of real estate within the Borough who rents or leases any parcel of real estate, or other or personal property, in whole or in part to any other persons for residential purposes, shall file with the authorized agents of the Borough a certified list of all persons who rent real estate from said owner each time there is a change in tenants. Said list shall include the name of each adult (person over the age of 18) who is renting said rented real estate or property for all or a portion of any 12-month period. The landlord shall complete the registration on forms provided by the Borough for the purposes of such registration.

Section 2.

There shall be no fee charged to the landlord for the filing of each registration.

Section 3.

Every owner shall have up to thirty (30) days after the change of tenants occurs to file with the Borough the completed registration on the forms designated by the Borough. After thirty days citations shall be issued in accordance with Section 4 of this Ordinance.

Section 4.

Every owner of real estate who fails to comply with the requirements of this Ordinance shall, upon summary conviction before the District Justice, be liable for a civil penalty in the amount of \$300, and shall also be liable to reimburse the Borough for any costs, filing fees, attorney's fees, and other expenses incurred by the Borough in enforcing the provisions of this Ordinance against such person. For the purpose of this ordinance, every day that an owner of real estate or other person obligated to provide a registration on the form designated by the Borough under this ordinance is late in filing as required above shall constitute a separate offense. The code

enforcement officer for the Borough or other officials designated by Council shall enforce the provisions of the Ordinance.

Section 5. Severability

The provisions of this Ordinance are severable. If any part of this Ordinance is declared to be unconstitutional, illegal or invalid, the validity of the remaining provisions shall be unaffected thereby.


Section 6: Repealer


