## West Wyoming Ordinance 2 - 2011

AN ORDINANCE CREATING A RECREATION BOARD OF THE BOROUGH OF WEST WYOMING; PROVIDING FOR APPOINTMENTS AND ORGANIZATION: STATING THE AUTHORITY AND RESTRICTIONS ON POWERS OF THE BOARD.

The West Wyoming Borough council hereby ordains:

- 1. Creation of Board; Membership. There is hereby created a Recreation Board in and for the West Wyoming Borough. The Board shall consist of no less than five (5) persons and no more than nine (9) to be appointed by the West Wyoming Borough Council for such terms as shall permit no more than two terms to expire in any one (1) calendar year.
- 2. Appointments; Terms of Office. The members of the Board shall be appointed by the Borough of West Wyoming for terms of five (5) years, in such order that at least one member's term shall expire annually; the aforesaid appointment for a specified term notwithstanding the West Wyoming Borough retains its right to remove any member of the Board, at the pleasure of the West Wyoming Borough Council by majority vote.
- 3. Service Without Pay; Vacancies. The members of the Board shall serve without pay and vacancies in such Board, occurring otherwise than by expiration of a term, shall be filled by the West Wyoming Borough Council for the unexpired term in the same manner as original appointment.
- 4. Officers and Directors of Recreation. The Recreation Board shall elect its own chairman and secretary and any other officers deemed necessary, to serve for a period of one (1) year. A Director of Recreation or Chairman shall be designated to serve as the administrative officer of the Recreation Board and shall be directly responsible to the West Wyoming Borough Council for the performance of his/her duties.
- 5. Annual Budget. The Recreation Board, at such times as directed by the Borough of West Wyoming shall annually submit for approval to the West Wyoming Borough Council a proposed budget for the ensuing year, setting forth all proposed expenditures, salaries and programs. The Recreation Board shall not in any manner obligate the Borough of West Wyoming for the payment of any municipal funds until the same is appropriated by the West Wyoming Borough Council.

- 6. Restrictions and Authority of Board. The Recreation Board Shall exercise the authority granted herein over any recreation place acquired hereafter or not existing, unless otherwise specified by the Borough of West Wyoming.
- 7. Repeal. All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed. The following ordinances or parts thereof are specifically repealed.
- 8. Effective Date. This ordinance shall become effective on June 5, 1985.
