

**ORDINANCE**

WEREAS THE DISTRIBUTION OF CIRCULARS, HANDBILLS AND ADVERTISING LEAFLETS OR PAMPHLETS HAS RESULTED IN THE LITTERING OF THE STREETS, SIDEWALKS AND LAWNS IN THE BOROUGH OF WEST WYOMING, THEREBY CAUSING AN UNSIGHTLY CONDITION AND MUCH ANNOYANCE TO THE RESIDENTS OF THE BOROUGH;

AND WHEREAS IT IS THE DESIRE OF THE COUNCIL AND BURGESS TO REGULATE THE SAME IN SUCH MANNER AS TO ELIMINATE THE CONDITION AND THE ANNOYANCE TO THE RESIDENTS, WITHOUT INFRINGING UPON THE RIGHT TO ALL PERSONS TO DISSEMINATE INFORMATION IN A LEGAL MANNER;

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WEST WYOMING, PENNSYLVANIA, AS FOLLOWS:

SECTION I. THAT FROM AND AFTER THE PASSAGE OF THIS ORDINANCE IT SHALL BE UNLAWFULL FOR ANY PERSON OR PERSONS, FIRM OR CORPORATION, TO THROW, PLACE OR BE A PARTY TO THE THROWING OR PLACING, EITHER AS PRINCIPAL OR AGENT, OF ANY CIRCULARS OR HANDBILLS OR OTHER ADVERTISING MATTER ON ANY THOROUGHFARE OF THE BOROUGH, OR ON OR IN ANY VEHICLE, POLE, POST OR OTHER OBJECT IN ANY THOROUGHFARE, OR TO THROW OR PLACE ANY ADVERTISING MATTER ON THE STEPS, ENTRANCE OR PREMISES OF ANY BUILDING IN THE BOROUGH, OR TO HAND ANY ADVERTISING MATTER TO ANY PERSON IN ANY THOROUGHFARE OF THE BOROUGH.

THE PURPOSE OF THIS ORDINANCE IS TO PREVENT ANNOYANCE TO THE PUBLIC AND THE LITTERING OF THE PUBLIC THOROUGHFARES BY THE FREE DISTRIBUTION OF ADVERTISING MATTER.

SECTION II. THAT ANY PERSON, FIRM OR CORPORATION VIOLATING ANY OF THE PROVISIONS OF THIS ORDINANCE SHALL, UPON CONVICTION THEREOF BEFORE THE BURGESS OR ANY JUSTICE OF THE PEACE OF THE BOROUGH, PAY A FINE OF TEN (\$10) DOLLARS OR, IN DEFAULT OF PAYMENT THEREOF, BE COMMITTED TO THE COUNTY JAIL FOR A PERIOD OF TEN (10) DAYS.

SECTION III. THAT ANY AND ALL ORDINANCES, OR PARTS THEREOF, INCONSISTENT WITH THE PROVISIONS OF THIS ORDINANCE, BE, AND THE SAME ARE HEREBY REPEALED.
