## ORDINANCE

AN ORDINANCE OF THE BOROUGH OF WEST WYOMING, LUZERNE COUNTY, PENNSYLVANIA, IMPOSING AND FIXING A CHARGE FOR GARBAGE COLLECTION SERVICES IN THE BOROUGH AND PROVIDING FOR PENALTIES FOR NONCOMPLIANCE THEREWITH.

WHEREAS, the Borough of West Wyoming is in need of moneys to help defray the costs of such garbage collection services,

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Mayor and Borough Council of the Borough of West Wyoming, Luzerne County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1: That effective January 1, 1996, for the purpose of helping to defray the costs of garbage collections in the Borough of West Wyoming, the sum of \$90.00, annually, is imposed on the occupant occupants of each dwelling unit. (A dwelling unit consists of one or more rooms for living purposes; together with separate cooking and sanitary facilities used or intended to be used by one or more persons living together and maintaining a common household, and accessible from the outdoors, either directly or through an entrance hall shared with other dwelling units.)

SECTION 2: Garbage will be collected from business places, only if the living quarters of the business owner forms part of the same building. In such cases the maximum garbage collected, per collection, shall be three (3) bags or three (3) containers, or a combination of both, totaling not more than three (3).

SECTION 3: The aforesaid charge shall be paid to the West Wyoming Borough Treasurer on or before the 15th day of January, 1996, I thereafter on or before the 15th day of January of each and every

year.

SECTION 4: Any person setting out garbage for collection, who has not paid the above fees, shall be guilty of littering, and upon conviction thereof before the District Magistrate, shall have a fine of not more that \$300.00 imposed upon them.

EXCEPTION: Persons not having a borough issued garbage sticker shall produce a signed contract with a hauler of their own choice or shall be guilty of littering. Any person or business not abiding by either condition must report in writing the method by which they dispose of their garbage to the West Wyoming Borough Council. The term garbage will be defined in the contract signed by the borough hauler each contract term.

SECTION 5: This ordinance in its entirety shall be enforced by the West Wyoming Borough Police and Borough Council.

SECTION 6: All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.
