**Gary Stavish**: Chairman-Personnel

Randy Colalrusso: Public Facilities

Councilman Colarusso stated that there was no reading of the Treasurer's Report due to computer crashing.

DPW are processing yard waste, cutting grass, patching potholes and working on creek repairs for upcoming inspection.

**Daniel Grescavage**: Community Development/Recreation:

Councilman Grescavage announced that road work repair will begin on June 22 on W. 8<sup>th</sup> Street. This is due to the flooding from 2006 that washed away the edge of the road. Kingston Twp. was fixed last year and this year will be West Wyoming. Mt Zion will be the alternative route to use.

Mike Dolan: Public Safety/Code Enforcement

West Wyoming Emergency Services responded to fifty-nine alarms in May: 45 EMS calls- 3 engine company assists-5 rescue company assists-3 commercial fire alarms- two motor vehicle accidents- one

open burning complaint. Hose Co # 1 is currently hiring EMT's for duty crew positions. Applications can be obtained from any member or by calling 693-3660.

On Code Enforcement – Received Ken Shefler's engagement letter. Ken will be meeting with Ann Marie on Tuesday morning to go over complaints on Tripp Street. Illegal dumping has gotten better after the police started issuing citations at the Recycling Area. There will be additional traffic shifts on the corner of Shoemaker and Sixth St. The police completed training on NRAD Equipment. We received Penn East Pipeline Grant. AED's are going to be purchased.

Called for an Executive Session about the WVSA Storm Water Project.
